We started off the month with the bank balance at \$9,808.39. At area, we had literature orders of \$668.28 with donations of \$143.22. Activities committee did a great job making money bringing their prudent reserve back up on top of donating an extra \$36. The total deposit made to the bank is \$1,247.50. All checks had cleared the bank since last area and now have two pending checks being \$30 for area rent and the \$225 we voted to donate to Region. H&I had an order of \$141.70. We have a tentative lit order of \$1,115.43. After prudent reserve and expenses, we have \$227.26 available left in the account. With H&I having started back up, it may get to the point soon where we are not able to provide H&I with what they are requesting unless we start seeing more donations. We did vote on halting the accrual of Newsletter and only keeping \$100 in there until Newsletter starts back up. That was \$133.24 thrown back into available cash which pretty much covered H&I this month.
